

## HOW TO COMPLETE THE FORM – OPTING BETWEEN THE EU AND NON-EU RESIDENCE CARD

### You should complete and submit this form, if:

- You register your residence and apply for issuance of a Residence Card before 31 December 2020; or
- Your current Residence Card expires in 2020 and you apply for a new one before 31 December 2020.

**However, we advise to have this form completed and submit it in case of all applications filed before 31 December 2020.**

Add the city/town of your competent Foreign Police Department and its address.

Add your personal details.

Tick **only one** of these three options:

Tick the **first** option, if you wish to receive an EU Residence Card. If you select this option, please be aware that this Card will only be valid until 30 June 2021 and you will need to exchange it for a non-EU Residence Card before this date.

Tick the **second** option, if you wish to receive a non-EU Residence Card and if you have lived in Slovakia for **less than 5 years**. This Card will be valid for up to 5 years and you will not need to exchange it (as in the case of the EU Card).

Tick the **third** option, if you wish to receive a non-EU Residence Card and if you have lived in Slovakia continuously for **more than 5 years**. This Card will be valid for up to 10 years and you will not need to exchange it (as in the case of the EU Card).

If you have lawful residence in Slovakia before 31 December 2020, you will not lose your right to live, work, study etc. by opting for the non-EU Residence Card. In such case, your new non-EU status will allow you to enjoy your rights broadly as you did before in the territory of Slovakia.
