

GUIDE HOW TO COMPLETE THE APPLICATION FORM

Applicable only for UK nationals and their family members who are Withdrawal Agreement beneficiaries.

You should complete this application form if:

- You are exchanging your EU Residence Card for the non-EU Residence Card; or
- You are registering your residence and applying for a Residence Card for the first time

For official use only.

You need to strike out the options that don't apply to you. This depends on your situation:

- If you are exchanging your EU Residence Card for the non-EU Residence Card, regardless if you are a UK national or a UK national family member, strike out all but the last option.
- If you are a UK national, registering residence for the first time, strike out the first, second and fourth option. Leave the third and last.
- If you are a UK national family member registering residence for the first time, strike out all but the fourth option.

Indicate your family name, as stated in your passport.

Indicate all your first names, as stated in your passport.

Indicate your family name (surname) at birth.

If you are a Withdrawal Agreement beneficiary, you will not lose your right to live, work, study etc. by applying for the non-EU Residence Card. Your new non-EU status will allow you to enjoy your rights broadly as you could before, in the territory of Slovakia.
